## Republican Committee

We are three weeks since the election and I am pleased to report the following:

1. We continue to appoint qualified committee people, and I appreciate the efforts made to submit qualified candidates.
2. Some of our Officers and Advisory Board met with all of the Republican nominees or their representative on Thursday, July 11 and had a very open and frank discussion on what was needed for each candidate to prevail in November's Election and how the Committee could best ensure that result. The Committee made a number of requests of the candidates and provided each candidate with a list of questions to answer in order to provide feedback to the committee. We expect responses to our requests to the endorsed candidates to be received shortly for review and follow up.

Some of our Officers and Advisory Board met with the Row Officers on Friday, July 12 to discuss how the Committee could best serve them and provided each Row Officer with a questionnaire for them to fill out in order to provide feedback to the committee. The meeting was very fruitful, and ideas and suggestions were shared by both sides.
4. I have appointed the following persons to be Vice Chairs for the Committee: Debbie Anderson, Kingsley Blasco, Louisa Gaughen, Bobbye Gregory, and Richard Tomredle.
5. I have appointed the following persons to serve on the Advisory Board based on geographical region: Debbie Keys, Kaytee Moyer-Isely (YRs), David Buell, Dean Villone, Don Giestwhite, Andrew Barbin, Theresa Myers (CCCRW), Laszlo Pasztor and Stacy Gromlich.
6. I have appointed the following persons as Chairs for those committees contained in the Bylaws and have appointed the following persons to serve on each committee: Please refer to the attached organizational chart.

8. We are in the process of scheduling a meeting with all of Cumberland County's state elected officials and will be asking them to complete a questionnaire similar to the one given to the county elected officials on how the committee can best serve them.



10. I met with Senator Mike Regan on Thursday, July 11 and we confirmed our commitment to act in the best interests of the party in order to ensure success in the Fall and 2020 elections. I appreciate the Senator's efforts to unite our party and pledge that I will do the same.

11. A number of our committees will be having kick off meetings this week or next week and will report to the Committee on the progress being made. There are a limited number of committee positions currently available due to the significant interest we received from committee members. Thank you for agreeing to serve.
